Pulse Polio program was carried out from time among the tribal & backward classes with help of local Govt. authority. This program was under taken for eradication of polio from society.

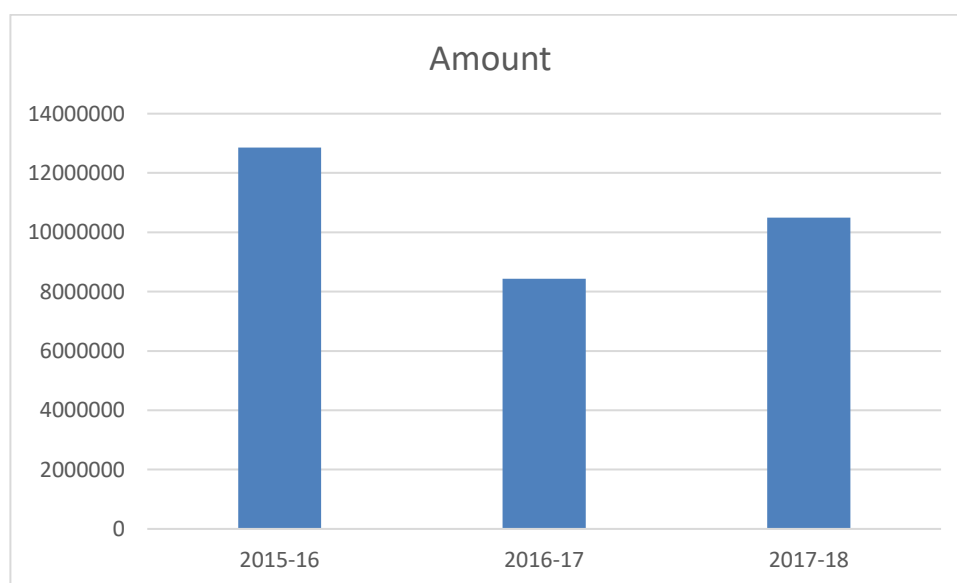
**SOCIAL DEVELOPMENT PROGRAMME:**
